RULES & REGULATIONS

Actual valid competitions rules of the World Taekwondo (WT) also Competition Rules (WOT) of the German Taekwondo Union (DTU) shall be applied. Deviations from these competitions rules require approval from the protest committee at the competition day.

All participants must be affiliated members of the DTU, WTE or WT.

METHOD OF COMPETITION

Single elimination system. Rounds, fight- and breaktime will be decided at the completion day.

AWARDING/ RESULTS

The Club and Team Awarding can be determined in conclusion of individual results, as following:

- 1 point for the start of each competitor,
- 1 point for the victory of each fight,
- 120 points for 1. place,
- 50 points for 2. place,
- 20 points for 3. place,
- 50 points for uncontested fights

Should two or more Teams have the same amount of points, the result will be determined according to the numbers of Gold, Silver and Bronze medals at first.

Afterwards according to the numbers of participants and thereafter according to more points in higher weight divisions.

IDENTIFICATION

According to the rules & regulations of the German Taekwondo Union all competitors need to have a valid personal document / passport.
Only members of national federation's affiliation with the WTE are allowed to compete. For countries without any federation being member of the WTE, affiliation with WT is necessary. Upon onsite registration, the contestants must prove their memberships by means of a valid license.

COACHES

1 coach(es) for every 4 competitors has free admission. A maximum of 4 coaches per team is allowed. The minimum age for a coach must be 18 years old and the coach is only allowed in sportswear & sports shoes with non-marking outsoles

REFEREES

International and / or national referee also regional referees will be used

DECLARATION OF CONSENT

All competitors who are minor (under legal age of 18 years) at the day of the tournament need a declaration of consent by a legal guardian which must be brought to the tournament and presented on request.

PROTEST

Only the official coach is allowed to protest immediately after the end of the contest. A protest fee need to be paid for each protest. The decision of protest committee (chairman) is final. The protest fee will be returned if the protest was found valid.

Protest fee: 100 €

LIABILITY DECLARATION

Every person participates at their own risk. With the registration, each contestant or their legal guardian agrees explicitly to the exclusion of liability. Promoter and Organizer do not assume liability for any damage to persons or property!
Meals and beverages are not allowed to be consumed on tribune and changing rooms.

DATA PROTECTION

With registration the athletes / officials, agree to storage personal data, the processing and the use of them related as far as they are required for tournament / club / association purposes to complete the sports operation.

ANTIDOPING

With the participation the competitor accepts the agreement with the NADA/WADA Info: www.nada.de
All participants accept the NADA Code at it latest version (2015), and with their participation they agree to the application of the Antidoping regulations.
