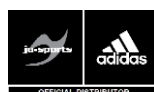

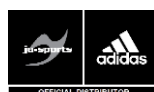

## IDENTIFICATION

According to the rules & regulations of the German Taekwondo Union all competitors need to have a valid passport.  
Only members of national federation's affiliation with the WTE are allowed to compete. For countries without any federation being member of the WTE, affiliation with WT is necessary. Upon onsite registration, the contestants must prove their memberships by means of a valid license.

## COACHES

1 coach for every 5 competitors has free admission. A maximum of 4 coaches per team is allowed. Coaches must be registered in TPSS.

The minimum age for a coach must be 18 years old and the coach is only allowed in sportswear & sports shoes with non-marking outsoles. A towel is to be carried.

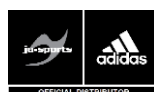
## PROTEST

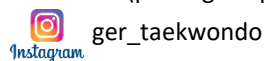
